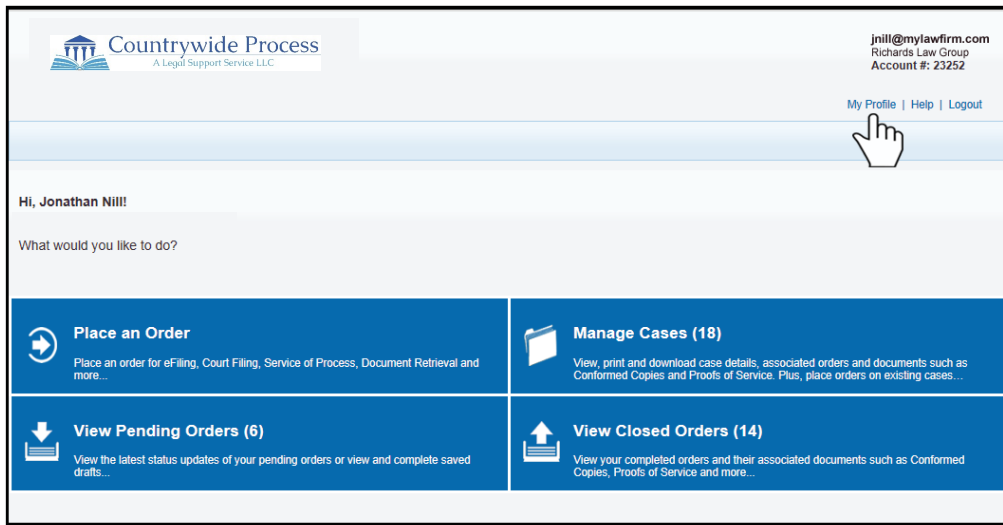


## USERGUIDE

 To make changes to your **Account Information**, click on the "Edit" button.




## USERGUIDE
